- **Clinton Isham** is an enrolled member of the Lac du Flambeau Band of Lake Superior Anishinabe. He works at the Great Lakes Inter-Tribal Council as the Program Director for the Wisconsin Native American Tobacco Network. Clinton is a proud father and community activist.

## Lisa Myers

- **Lisa Myers** is the Health and Wellness Manager with the Sault Sainte Marie Tribe of Chippewa Indians Community Health Department. She has extensive experience in community service, public health education and family programming spanning the lifecycle, birth through the elderly. Lisa currently manages Sault Tribe's Health Education Programs and is Principle Investigator for multiple grant projects for the Sault Tribe's Health Division.

## Suzanne Nash

- **Suzanne Nash** has worked in Tobacco control for 15 years. Suzanne has facilitated and coordinated tobacco cessation, education and policy work with 11 tribes in Minnesota and the urban area. She has worked at Indigenous Peoples Task Force for close to 16 years, as a Tobacco Program Manager, Housing Director, Medical Case Management Supervisor and as a Youth Coordinator for the Waybingay Curriculum (Focus is on tobacco prevention, cessation and alcohol and drugs). For the past 13 years, Suzanne has organized and facilitated statewide conferences around tobacco, cultural teachings, traditional foods, environmental issues and policy work.

## Steve Babb

- **Steve Babb** is a Public Health Analyst with the Policy, Planning, and Coordination Unit of the CDC Office on Smoking and Health (OSH). Steve has worked with OSH in a variety of capacities for the past seventeen years.
